**WESTERN CAPE GAMBLING AND RACING ACT, 1996 (ACT 4 OF 1996)  
WESTERN CAPE GAMBLING AND RACING REGULATIONS  
(FEES AND COSTS), 2016: DRAFT AMENDMENT, 2025**

The Provincial Minister of Finance in the Western Cape, under section 81(1)(m) and (n) of the Western Cape Gambling and Racing Act, 1996 (Act 4 of 1996), intends to make the regulations set out in the Schedule.

**SCHEDULE****Definition**

1. In these regulations “the Regulations” means the Western Cape Gambling and Racing Regulations (Fees and Costs), 2016, published under Provincial Notice 97/2016 dated 31 March 2016 and amended by Provincial Notices: 81/2017 dated 24 March 2017, 45/2018 dated 26 March 2018, 36/2019 dated 26 March 2019, 28/2020 dated 25 March 2020, 37/2021 dated 9 April 2021, 39/2022 dated 30 March 2022, 34/2023 dated 31 March 2023 and 34/2024 dated 28 March 2024.
