PROVINCIAL NOTICE**P.N. 73/2025****18 June 2025****FEES (HERITAGE WESTERN CAPE) 2025**

Heritage Western Cape, in terms of regulation 2(3) of the Regulations made by Heritage Western Cape in terms of Section 25(2)(h) of the National Heritage Resources Act, 1999 (Act 25 of 1999) (the Act) (NHRA), published under Provincial Notice 298 in *Provincial Gazette* 6061 dated 29 August 2003, determines the following fees in respect of services rendered in terms of the Act to be applicable as of 1 July 2025.

1. Fees

The fees payable in respect of the provision of services rendered in terms of the National Heritage Resources Act, 1999, are as set out in the Schedule.

2. Waiver of fees

If a person who utilises the services contemplated in regulation 2 is unable to pay the fees, he or she may apply in writing to the Chief Executive Officer of Heritage Western Cape for the fees to be waived.
